## **SYNOPSIS**

This contract shall be partially reimbursed with Federal-aid funding through the North Carolina Department of Transportation (hereinafter referred to as the Department). The solicitation, selection, and negotiation of a contract shall be conducted in accordance with all Department requirements and guidelines.

Subconsultants are permitted under this contract. The primary and subconsultant firms shall be pre-qualified by the Department to perform any of the Discipline Codes listed below for Brunswick County.

**00045, Corridor Planning-** Must show expertise and experience in corridor planning, coordinating existing and future land use and the multimodal transportation system to provide guidance as development occurs. Must have a current TransCAD license. Must show ability to use TransCAD and Micro Simulation.

**00141-** Multimodal Transportation Planning- Must show expertise in development of a Transportation Plan which considers various modes of transportation and connections between them.

This RFLOI is to solicit responses (LETTERS of INTEREST, or LOIs) from qualified firms to provide professional consulting services to:

# **PROJECT BACKGROUND**

The Grand Strand Area Transportation Study (hereinafter "GSATS") is requesting letters of interest (LOI) for professional services from a qualified consultant to develop a Corridor Study (hereinafter "Plan" or "Project"). This study proposal submitted by the Town of Sunset Beach was selected for funding through GSATS' Local Direct Attributable (DA) Funds Program. The study area consists of the entire municipal limits of the Town of Sunset Beach along with its adjacent extraterritorial jurisdiction.

The Town of Sunset Beach is experiencing tremendous growth on the NC904 Corridor. The corridor is impacted by multiple subdivisions both existing and approved for development. Subdivisions in the Town include the Sanctuary, Villas at Seaside, Sunset Ridge and Ocean Ridge (Jaguars Lair). The corridor includes a Mixed-Use Zoning District.

NC904 is one of three accesses to the beach, one of three emergency egresses, and the most highly stressed (89% capacity per comp plan) route. The population in Sunset Beach triples during the summer season and is increasing in both the spring and fall shoulder seasons.



The Town seeks to address recent growth that has stressed the capacity of the roadway and anticipated future growth. The town also seeks to improve access to local beaches on which the local economy is based and safer transportation opportunities for vehicles, pedestrians, and cyclists including amenities such as sidewalks, bike lanes, and/or multi-use paths where appropriate.

This study will address both the long-term projects and near-term issues such as access management techniques/policies to implement as the corridor builds out. Consideration to consolidate and/or integrate TIA findings for the subdivisions and commercial development.

This study will help guide policy and strategy to plan for Integrating and assimilating multiple (private) received and anticipated transportation impact assessments and create a safe functioning corridor. Drawing on environmental suitability data, land use, population and development projections, and public input, this study will identify any regulatory strategies needed to guide access management along the corridor as private development increases. Regulatory strategy recommendations may pertain to easement acquisition, changes in the town's zoning ordinance, and other mechanisms. This study will also inform design standards for amenities to serve various modes where appropriate. Consideration will also be given to the Growth areas surrounding the corridor that will directly impact the road.

The Town of Sunset Beach intends to seek funding through the Regional Impact and Division Needs categories within SPOT. In these categories there is a heavier emphasis on local input points which are approved by the GSATS TAC.

Except as provided below, any firm wishing to be considered must be properly registered with the Office of the Secretary of State and with the North Carolina Board of Examiners for Engineers and Surveyors. Any firm proposing to use corporate subsidiaries or subcontractors must include a statement that these companies are properly registered with the North Carolina Board of Examiners for Engineers and Surveyors and/or the NC Board for Licensing of Geologists. The Engineers performing the work and in responsible charge of the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest. Firms which are not providing engineering services need not be registered with the North Carolina Board of Examiners for Engineers and Surveyors. Some of the services being solicited may not require a license. It is the responsibility of each firm to adhere to all the laws of the State of North Carolina.

The firm must have the financial ability to undertake the work and assume the liability. The selected firm(s) will be required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00. The firm(s) must have an adequate accounting system to identify costs chargeable to the project.

## **SCOPE OF WORK**

The respondent's LOI package must meet or exceed the project tasks specified below in this work statement. The respondent will use their technical expertise, professional experience, and creativity when developing a LOI package designed to meet the specifications of this work statement. As such, respondents may propose a method or collection that differs from those processes or tasks listed in the work statement to produce a sounder study. Two public meetings will be required for this project.

## Project

This project is a Corridor Study that will compile and package all existing information on the Seaside Drive/NC 904 corridor from US 17 to Sunset Boulevard, including:

• Approved and proposed planning documents, transportation impact assessment studies, traffic count information and accident reports;

- Inventory, describe and evaluate relevant factors, issues, current and anticipated problems and opportunities for both short-term management and long-term solutions; and
- Establish a framework plan for the management and improvement of the corridor.

# **Project Schedule**

The consultant will provide detailed project schedule outlining the proposed completion of the following major phases in the 6-month study process:

# Task 1: Data Collection

The consultant will collect all data necessary to complete a comprehensive evaluation for the corridor study area. Relevant data includes (but not limited to):

- Parcel and tax data;
- Developments (existing and planned) located within and around the study area;
- Available infrastructure and existing utility easements (Water, sewer, electricity, etc.);
- Potential construction limitations (zoning, flood zones, protected species, wetlands, historic sites, etc.);
- Existing roadway data (public and private) including surface type, current and projected future traffic volumes- daily and peak volumes) and turning movement counts at the NC 179 Old Georgetown Road/NC 904 Seaside Road intersection. Consultant will use the GSATS Model for data and coordinate with NCDOT;
- Analysis of existing right-of-way constraints;
- Design characteristics of intersections and other access points to existing roadways;
- Planned roadway improvements;
- Existing land uses;
- Applicable zoning regulations;
- Applicable subdivision regulations and suggested modifications; and
- Most recent crash data

Data may be available from the Town of Sunset Beach, GSATS, and NCDOT. Where appropriate, GSATS staff will assist the consultant in locating appropriate data; however, the consultant will be responsible for verifying key attributes of these datasets. Fieldwork may be necessary to verify the data assembled for the project. The consultant should review adopted plans and policies relevant to the corridor study area.

# Task 2: Mapping of Environmentally Crucial and/or Unsuitable Areas

The consultant will identify environmentally sensitive areas along this corridor to minimize impacts by addressing any previous environmental analysis and planning for land use in the study area and solicit comments from appropriate regulatory agencies.

## Task 3: Existing Conditions Assessment, Projection of Growth Areas

The consultant will inventory current land uses, zoning, and current traffic burden through this corridor with emphasis at the intersection of NC 179 Old Georgetown Road/NC 904 Seaside Road to determine current population mobility and access needs and their level of attainment. The analyzed data will be synthesized with building permit data, the unified development ordinance, other plans pending or in place, environmental analysis, and any other applicable information or expertise to develop a comprehensive projection of future growth.

# Task 4: Identification of Improvements on the Corridor

The consultant will identify improvements on the corridor to accommodate current and future growth based on growth area projections, current demand, and travel demand modelling analysis based on these data. The consultant will identify environmental and engineering constraints for these improvements. Consultant should produce maps of the projects throughout the corridor showing data layers used to determine the project types.

# Task 5: Corridor Alternatives

The consultant will identify both existing and proposed corridor improvements projects including multimodal infrastructure, streetscapes, access management, and safety improvements. This process will involve land use data, NCDOT standards, and public input. These illustrations should include recommended conceptual designs and context-sensitive cross-sections for corridor improvements and planning in the study area. Work effort not to exceed 10% design.

# Task 6: Recommendations for Planning and Regulatory Strategy

The consultant will list recommendations and strategies for intersection improvements and corridor recommendations through public and private development and/or public ROW acquisition. Recommendations and strategies should be based on local ordinances, state laws, NCDOT requirements, and best practices within these constraints where available or applicable.

# Task 7: Public Involvement and Input

The proposal should include a detailed description of how the Consultant proposes to engage the public in the planning process and ensure the recommendations are considered for the final plan. Public participation and engagement are required to help formulate a plan that is consistent with the vision of the community.

The Consultant will hold the first public meeting to present findings and initial recommendations to the public and solicit public input.

## **Task 8: Draft Corridor Study Project Recommendations**

The Consultant will prepare a draft report that identifies the recommendations of the study. Essential materials to be included in the draft report include a compendium of data collected for the project, maps of existing conditions in the study area, environmental and engineering constraints, growth areas, and corridor determinations with supporting text and illustrations addressing the following:

- Recent growth that has stressed the capacity of the roadway and anticipated future growth;
- Access to local beaches on which the local economy is based;
- Integrating and assimilating multiple (private) received and anticipated transportation impact assessments;
- Considering streetscape concepts;
- Integrating multimodal elements (illustrations of design standards for bicycle and pedestrian facilities, etc.);
- Capacity improvements that can be achieved via access management and other techniques;
- Intersection improvement recommendations;
- Access management considerations; and
- Assignment of lead and supporting entities needed to complete the projects.

The draft should include a summary of the procedures used by the consultant to develop the recommendations and strategies outlined in the plan.

The Consultant will hold the second public meeting to present the draft plan.

# **Task 9: Steering Committee Review**

The Steering Committee will undertake a final review of the draft report and recommend revisions deemed necessary. Following review of the draft report (and any revisions), the Steering Committee will endorse a Final Report once it is deemed complete.

# Task 10: Final Report

The consultant will be responsible for presenting the final document to the Sunset Beach Town Council and Transportation Advisory Committee (TAC).

The consultant will provide copies of the Final Report in the following formats:

- One (1) Digital copy to the Town of Sunset Beach
- One (1) Digital copy to GSATS
- Three (3) Hard copies to the Town of Sunset Beach
- Three (3) Hard copies to GSATS

# **SELECTION PROCESS**

Following is a general description of the selection process:

- The Steering Committee will review all qualifying LOI submittals.
- <u>For Project-Specific Contracts</u> (non On-Call type contracts), the Steering Committee will shortlist firms to be interviewed. The dates of shortlisting and dates for interviews are shown in the section SUBMISSION SCHEDULE AND KEY DATES at the end of this RFLOI.
- To be considered for selection, consultants must submit a complete response to this RFLOI prior to the specified deadlines. Failure to submit all information in a timely manner will result in disqualification.
- The GSATS MPO will negotiate a final contract with the most qualified firm.

The participation shall be submitted on the Department's Subconsultant Form RS-2. RS-2 forms may be accessed on the Department's website at <u>NCDOT Connect Guidelines & Forms</u>. The SPSF must be qualified with the Department to perform the work for which they are listed.

## PREQUALIFICATION

The Department maintains on file the qualifications and key personnel for each approved discipline, as well as any required samples of work. Each year on the anniversary date of the company, the firm shall renew their prequalified disciplines. If your firm has not renewed its application as required by your anniversary date or if your firm is not currently prequalified, please submit an application to the

Department **prior to submittal of your LOI**. An application may be accessed on the Department's website at Prequalifying Private Consulting Firms. Learn how to become Prequalified as a Private Consulting Firm with NCDOT. Having this data on file with the Department eliminates the need to resubmit this data with each letter of interest.

Professional Services Contracts are race and gender neutral and do not contain goals. However, the Respondent is encouraged to give every opportunity to allow Disadvantaged, Minority-Owned and Women-Owned Business Enterprises (DBE/MBE/WBE) subconsultant utilization on all LOIs, contracts and supplemental agreements. The Firm, subconsultant and sub firm shall not discriminate on the basis of race, religion, color, national origin, age, disability or sex in the performance of this contract.

# **SELECTION CRITERIA**

All prequalified firms who submit responsive letters of interest will be considered. In selecting a firm/team, the steering committee will take into consideration the following qualification:

35% = Specialized experience and technical competence of the respondent's assigned staff relative to the task requirements outlined in the Scope of Work:

- A. Experience of the prime contractor and subcontractor(s);
- B. Project Manager; and
- C. Other assigned individuals.

25% = Specialized experience of the firm to complete the project as outlined in the Scope of Work

A. Firm experience in completing similar projects/studies

**<u>30%</u>** = Understanding of the nature of the project and the firm's approach:

- A. Understanding of the proposed Scope of Work
- B. Respondent's proposed methodology and approach; and
- C. Organization and clarity of the proposal.

10% = References reflecting the previous work experience and product quality of the project team on comparable projects:

- A. Quality of final products
- B. Ability to meet work schedules; and
- C. Responsiveness to client input.

## SUBMISSION ORGANIZATION AND INFORMATION REQUIREMENTS

The LOI should be addressed to Elizabeth Tucker-Senior Transportation & Transit Planner, and must include the name, address, telephone number, and e-mail address of the prime consultant's contact person for this RFLOI. The LOI must also include the information outlined below:

# Introduction

The Introduction should demonstrate the consultant's overall qualifications to fulfill the requirements of the scope of work and should contain the following elements of information:

- Expression of firm's interest in the work;
- Statement of whether firm is on register;
- Statement regarding possible conflict of interest for the work; and
- Summation of information contained in the letter of interest.

# **Team Qualifications**

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- Identify recent, similar projects the firm, acting as the prime contractor, has conducted which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed and contact person. Please provide a minimum of three project references.
- If subconsultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

# **Team Experience**

This chapter must provide the names, classifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project.

GSATS is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project/Plan. A Capacity Chart/Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

<u>Note:</u> If a project team or subconsultant encounters personnel changes, or any other changes of significance dealing with the company, GSATS should be notified immediately.

## **Technical Approach**

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).

#### Subcontracting

If the Consultant is subcontracting with a subconsultant as part of this submission, the specific duties that each subconsultant will perform in this study will be detailed in the LOI/proposals. Each firm (or sub as applicable) will be rated on their specific experience performing the specific proposed role in the study.
